You are hereby notified that a Primary Election will be held on the 6th day of August, 2024, this being the first Tuesday in said month. At which time candidates for the following offices will be nominated according to the provisions of law by EACH of the political parties of this State who qualify to participate in said Primary Election as specified by law. Deadline to file for candidacy is Monday, June 3rd, 2024 by 12:00 P.M. unless filing as an Independent Candidate, at which time the filing deadline is Monday, August 5, 2024 at 12:00 P.M.

- One candidate for United States Representative 2nd District
- One candidate for State Senate 1st District
- One candidate for State Representative 63rd District
- One candidate for District Court Judge, 22nd District, 2nd Division
- One candidate for District Magistrate Judge, 22nd District 1st Position
- One candidate for County Commissioner 2nd District
- One candidate for County Commissioner 3rd District
- One candidate for County Attorney
- One candidate for County Clerk
- One candidate for Register of Deeds
- One candidate for Sheriff
- One candidate for County Treasurer
- One candidate for Township Trustee in each Township
- One candidate for Township Treasurer in each Township
