Shall the following be adopted?

Shall a countywide retailers' sales tax in the amount of one percent (1%) continue to be levied in Doniphan County, Kansas, for a period not to exceed five (5) years, to take effect October 1, 2025, with the revenue produced therefrom to be utilized for the following purposes: (1) to finance capital improvements to county owned property deemed necessary by the Board of County Commissioners of Doniphan County, Kansas, including, but not limited to, repairs and improvements to the Doniphan County Courthouse and repairs and improvements to the Doniphan County Law Enforcement Center; and (2) to purchase oil and chat and/or asphalt to make permanent improvements to county roads and repair existing hard surface roads; and (3) to assist with the funding of continued expenses incurred with updating and modifying the countywide 911 emergency system; and (4) to fund economic development incentives to attract new businesses and industry to the county and cities therein; and (5) pursuant to the provisions of K.S.A. 12-189 any funds generated from this sales tax which exceed the amount of revenue required to pay the costs of the special projects enumerated herein, shall be credited to the County General Fund to relieve the tax burden of the County?
